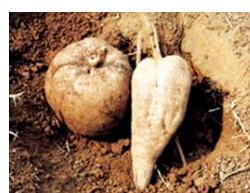

About Bamboo Salt

- ❖ The records of Bamboo Salt were found in the classic china medical books of WShen Nong's Herbal X & W Ben Cao Gang Mu X long in the history. Buddhist monks in Korea had manufactured them over a thousand years as an emergency drug.

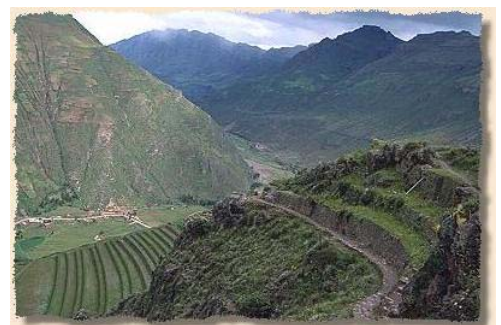
Manufacturing Process of Bamboo Salt

- ❖ The natural sea-salt from the West Coast of South Korea is chosen and filled into 3 years growth's bamboo trunks. After sealing the bamboos' opening with red clay taken from the deep mountain, it is baked for 9 times by using pine resin as the burning material at the temperature of 900°C-1500°C in order to eliminate the heavy metals and toxins in the salt.



A Fascinating History about MACA

- ❖ MACA, also known as Peruvian Ginseng is a plant cultivated only in the Andes of Peru, between 3,500 and 4,500 meters of altitude.
- ❖ It was first used by the Inca more than 2000 years ago for energy and endurance and is still commonly traded as a medicine and energy giving herb throughout the towns and villages of Peru today.
- ❖ It contains significant amounts of amino acids, complex carbohydrates, and minerals including potassium, calcium, phosphorous, zinc, magnesium, iron, and vitamins A, B1, B2, B4, B12, C, D and E, etc.

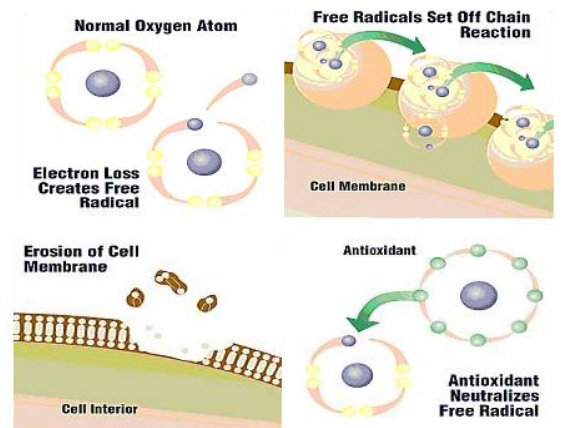
Tea Polyphenol

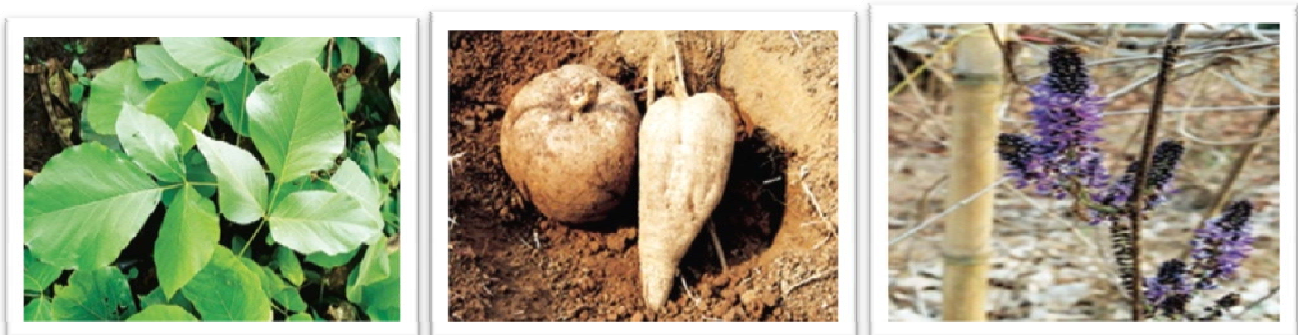
About Tribulus Terrestris in Vitca-M
